

ONLINE AZAN APP SUBSCRIPTION FORM

THIS SUBSCRIPTION AGREEMENT (The "Agreement") is entered into this ___/___/2025 (இன்றைய தேதி) , by and between the OnlineAzan mobile app ("App") owned by ETWENTY organisation ("Company") proprietorship of Mohamed Ismail Allapitchai, Tirunelveli and ("Masjid") **Masjid Name/ பள்ளிவாசலின் பெயர்**

having its place at (**Masjid Address/ பள்ளிவாசலின் முகவரி**)

WHEREAS, the Masjid expressing its desires to contract with Company to send the Masjid's Azan online using the App to the Masjid's community members in accordance with the terms of this Agreement; and WHEREAS, Company agrees to provided the requested service to the Masjid free of cost as set forth in this Agreement. NOW THEREFORE, in consideration of the above Recitals, which are hereby incorporated into the below Agreement, and in consideration of the mutual promises made herein, the receipt and sufficiency of which are hereby acknowledged, the Company and Masjid further agree as follows:

1. Masjid agrees to use the App solely for the purpose of sending the Masjid's Azan announcements online to the Masjid's community members
2. Masjid shouldn't use the App for any other communication such as giving Bayan or other announcements. Incase of using the App for communications other than the one mentioned in point 1 and if any consequences because of such communications is the responsibility of the Masjid and the company is not responsible for such communications & its consequences.
3. Masjid will submit a copy of the Aadhar proof of the Muezzin (or Imam or Secretary) whoever need to send Azan for purpose mentioned in point 1. The copy submitted will be attested by the signature Authority of the Masjid.
4. Company has full rights to terminate the agreement and stop the service incase the Masjid uses the App for any other communications other than the one mentioned in point 1.
5. Compensation. The Company doesn't charge any fee to the Masjid for providing the service and will not accept any payments from Masjid in relation to this.
6. The term of the Agreement shall be from ___/2025 to 12/2030 (**Month/ மாதம்**). The Agreement may be terminated earlier by Company in case of usage of the App for purposes other than the ones mentioned in point 1. The Company's Terms & Conditions are shared along with this application form & available in our website <https://onlineazan.com>. By signing the agreement Masjid has read & accept to it.
7. The Masjid can terminate the Agreement as they wish when they do not want to use the App
